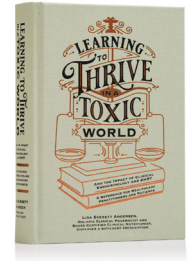
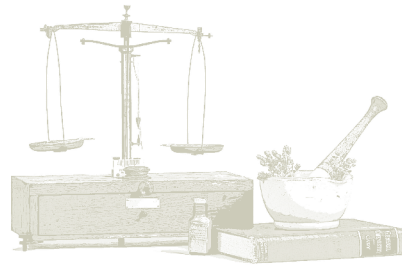


In the Name of Science (Additional Information)

Although In the Name of Science is already a long article, it was only the highlights of what people should know before they elected to jab. Pediatricians Get Paid to Push Vaccines - and It’s No Small Amount of Cash by Dr. Joseph Mercola.

“Primary care providers across the U.S. were bribed with incentive programs to coerce patients into getting the toxic COVID-19 shot. Anthem Blue Cross and Blue Shield paid doctors \$50 for each Medicaid patient aged 6 months and older.

Doctors have been financially incentivized to vaccinate children for a long time. In 2016, Blue Cross Blue Shield paid pediatricians a \$400 bonus for each patient that completed 10 vaccinations before their second birthday, provided 63% of their patients were fully vaccinated.

Using the average statistics from 1999, if a pediatrician has 1,000 patients, 264 can be expected to be 2 years old or younger. If all are fully vaccinated, the pediatrician would be eligible for a \$105,600 year-end bonus.

“Client and family incentives” also exist. In 2015, the Community Preventive Services Task Force recommended boosting vaccination rates by giving small, inexpensive incentive rewards to patients.

Bribery is also par for the course when it comes to vaccine mandates. Pfizer paid undisclosed sums to front groups that advocated for COVID-19 jab mandates, thereby hiding their conflict of interest.”
