Another Round of COVID-19 Nonsense

In early October (2023), the Lakeview Area News (Lakeview, MI) carried a couple articles titled “Poking the Covid-19 Skunk...” It is amazing how, in 2023, following study after study from around the world showing the predicted problems with COVID vaccinations, the problems with mask wearing, and the corruption around the entire COVID-19 response plan from the White House on down, we still have people contending everyone should get the latest updated COVID vaccine booster. I understand Travis Kelce of the Kansas City Chiefs making such statements, because he is getting paid a hefty endorsement fee from Pfizer for the ads.

In the following, I give many article direct quotes so as to not mince words or interpretation because the detractors, the people telling the public how safe and effective the COVID vaccinations are, repeatedly attack the messenger, ignoring the message.

Israel has been in the news lately regarding their war with Hamas, but nothing was covered on CNN, NBC, CBS or ABC regarding the death of Israel’s COVID-19 poster child, Yonatan Moshe Erlichman. UK - Death Trends for Malignant Neoplasms, Ages 15-44. Analysis of Individual Causes. UK Cause of Death Project Update. Date: October - 2023. Carlos Alegria: “In this study we investigate the UK trends in death rates for

malignant neoplasms for individuals aged 15 to 44 by computing excess death rates, which are the difference between observed death rates and a given baseline for expected death rates. We measure and compare changes in the behaviour of mortality patterns before the COVID-19 pandemic with the post-pandemic period for deaths with attributed to malignant neoplasms. We show a large increase in mortality due to malignant neoplasms that started in 2021 and accelerated substantially in 2022. The increase in excess deaths in 2022 is highly statistically significant (extreme event). The results indicate that from late 2021 a novel phenomenon leading to increased malignant neoplasm deaths appears to be present in individuals aged 15 to 44 in the UK. We also investigate the equivalent trends in deaths from individual ICD10 codes within malignant neoplasms (C00 to C99 codes). We analyse individually the 10 most common causes for malignant neoplasm deaths, and some causes of particular interest that are gender specific.”

Increased IgG4 synthesis due to repeated mRNA vaccination with high antigen concentrations may also cause autoimmune

diseases, and promote cancer growth and autoimmune myocarditis in susceptible individuals.”

The US Vaccine Adverse Event Reporting System, which is all we have presently in this country for collecting issues due to a vaccination, is problematic. “Our investigation has also found that, in stark contrast to the US government's handling of adverse reaction reports on drugs and devices, the publicly accessible VAERS database on vaccines includes only initial reports, while case updates and corrections are kept on a separate, back end system. Officials told *The BMJ* that this was to protect patient confidentiality—but this means that patients, doctors, and other public users of the database have access only to an incomplete and uncorrected version.”

Another issue is even more concerning. Young people are dying at much higher rates since the imposition the COVID vaccinations.

‘Excess mortality’ continuing surge causes concerns. Bailey. 2023. Insurance NewsNet: “Chow said there's a real question of whether the insurance industry can sustain the enormous payouts the excess mortality rates will dictate.”

“The real concern for life insurers lies in preparing for an unexpected wave of death claims and the impact on their assets under management,” she said. “Do they have enough reserves to weather these outflows, given the excess deaths? It's not just about death or health. It is about the industry's ability and readiness to manage this monumental outflow.”

“Capgemini just published its World Life Insurance Report that revealed the upcoming largest inter-generational wealth transfer in history that is expected to cause a massive outflow of nearly 40% of life insurers' assets under management (AUM), totaling \$7.8 trillion, by 2040.”

“When we factor in the rise of payouts on death claims, the magnitude of the situation demands urgent attention by the industry,” the report said.
